

Wings STM Appreciation Sweepstakes
April 1, 2021 – April 22, 2021

Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. VOID OUTSIDE PA, NJ AND DE AND WHERE PROHIBITED.

1. **ELIGIBILITY:** The Wings STM Appreciation Sweepstakes (the "Sweepstakes") is open only to Philadelphia Wings season ticket holders and entrants who are legal residents of Pennsylvania, New Jersey and Delaware, 18 years of age and older as of the date of entry. The following persons are not eligible to enter or win: employees of CS Philadelphia Lacrosse Team, LLC ("Sponsor"), the National Lacrosse League and its member teams and each of their respective parents, affiliates, subsidiaries, and advertising and promotion agencies and Prize Providers (as defined below), and the immediate families (spouse, parents, siblings and children, and their respective spouses, regardless of where they reside) and members of the households, whether or not related, of each of the above. The Sweepstakes is subject to all applicable federal, state, and local laws.

2. **HOW TO ENTER:** The Sweepstakes will commence on April 1, 2021 (the "commencement date") upon posting of the Official Rules and end on April 22, 2021 at 4:59:59 p.m. Eastern Time ("ET") (the "Promotional Period"). The Promotional Period will be divided into four (4) entry periods (each, an "Entry Period") as follows:

(a) the first Entry Period shall begin upon posting of the Official Rules on the commencement date and end at 4:59:59 p.m. ET on April 6, 2021;

(b) the second Entry Period shall begin at 5:00:00 p.m. ET on April 6, 2021 and end at 4:59:59 p.m. ET on April 12, 2021;

(c) the third Entry Period shall begin on at 5:00:00 p.m. ET on April 12, 2021 and end at 4:59:59 p.m. ET on April 17, 2021; and

(d) the fourth Entry Period shall begin on at 5:00:00 p.m. ET on April 17, 2021 and end at 4:59:59 p.m. ET on April 22, 2021.

If you are a Philadelphia Wings season ticket member during the Entry Period, you will be automatically entered to win. **If you are not a Philadelphia Wings season ticket member, you can enter as follows:** on a 3"x5" postcard, postage prepaid, print or type your complete name, street address, city, state, zip code, phone number and email address and mail it to: Wings STM Appreciation Sweepstakes c/o Philadelphia Wings Customer Service, 3601 South Broad Street, Philadelphia, PA 19148. Mail-in entries must be postmarked no later than the last day of the Promotion Period and received no later than 5:00 p.m. ET on April 28, 2021.

Sponsor's computer will be the official timekeeper for all matters related to this Sweepstakes. **LIMIT ONE ENTRY PER SEASON TICKET HOLDER ACCOUNT OR PER PERSON (IF ENTERING BY POSTCARD).**

3. **DRAWING:** Eighteen (18) potential winners will be drawn at random from all eligible entries on or about April 7, 2021 (for a combination of a Grand Prize, First Prizes, and Second Prizes [as defined

below]); ninety (90) potential winners will be drawn at random from all eligible entries on or about April 14, 2021 (for the Fifth Prizes and Sixth Prizes [as defined below]); Thirty (30) potential winners will be drawn at random from all eligible entries on or about April 21, 2021 (for the Third Prizes and Fourth Prizes [as defined below]); and thirty (30) potential winners will be drawn at random from all eligible entries on or about April 28, 2021 (for a combination of a Grand Prize, First Prizes and Seventh Prizes [both as defined below]) (for an aggregate of 168 potential winners). Sponsor reserve the right to delay any of the drawings. All non-winning entries received during each Entry Period will automatically be entered into each subsequent Entry Period until the entry is selected as a winner or the Promotional Period ends. Each potential winner will be notified via email and/or telephone (in Sponsor's discretion). Each potential winner must respond to email or voicemail notification within 72 hours, or he/she will forfeit the Prize (as defined below) and, at Sponsor's sole discretion, an alternate potential winner will be drawn at random from among all remaining eligible entries. Each potential winner may be required to execute and return, prior to and as a condition of receiving a Prize, an affidavit of eligibility and liability release and, except where prohibited by law, a publicity release. (b) Seven (7) first prizes (each a "First Prize" and, collectively, the "First Prizes"): Each First Prize consists of one (1) autographed item by a Philadelphia Wings player (choice of player to be in the sole discretion of Sponsor) (ARV of each First Prize: \$30; total ARV of the First Prizes: \$210.00);

(c) Fourteen (14) second prizes (each a "Second Prize" and, collectively, the "Second Prizes"): Each Second Prize consists of four (4) Philadelphia Wings branded coasters (ARV of each Second Prize: \$20; total ARV of the Second Prizes: \$280.00);

(d) Ten (10) third prizes (each a "Third Prize" and, collectively, the "Third Prizes"): Each Third Prize consists of one (1) Philadelphia Wings team issued beanie (ARV of each Third Prize: \$30.00; total ARV of the Third Prizes: \$300.00);

(e) Twenty (20) fourth prizes (each a "Fourth Prize" and, collectively, the "Fourth Prizes"): Each Fourth Prize consists of one (1) Philadelphia Wings facemask (ARV of each Fourth Prize: \$15.00; total ARV of the Fourth Prizes: \$300.00);

(f) Forty (40) fifth prizes (each a "Fifth Prize" and, collectively, the "Fifth Prizes"): Each Fifth

Prize consists of a Philadelphia Wings fan pack, consisting of a Philadelphia Wings branded t-shirt, pen, magnet, drawstring bag, and water bottle (ARV of each Fifth Prize: \$35.00; total ARV of the Fifth Prizes: \$1,400.00);

(g) Fifty (50) sixth prizes (each a "Sixth Prize" and, collectively, the "Sixth Prizes"): Each Sixth Prize consisting of a Philadelphia Wings branded scarf (ARV of each Sixth Prize: \$15.00; total ARV of the Sixth Prize: \$750.00); and

(h) Twenty-Five (25) seventh prizes (each a "Seventh Prize" and, collectively, the "Seventh Prizes"): Each Seventh Prize consisting of a Philadelphia Wings commemorative wooden ticket (ARV of each Seventh Prize: \$15.00; total ARV of the Seventh Prize: \$375.00).

The Grand Prizes, the First Prizes, the Second Prizes, the Third Prizes the Fourth Prizes, the Fifth Prizes, and the Sixth Prizes shall be referred to individually as the "Prize" and collectively as the "Prizes." The total ARV of all Prizes is \$3,875.00. ARV reflects unautographed merchandise.
