

**Wings Semifinals Playoffs Tickets Sweepstakes**  
**May 8, 2022 – May 11, 2022**

**Official Rules**

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. VOID OUTSIDE PA, NJ AND DE AND WHERE PROHIBITED.

1. **ELIGIBILITY:** The Wings Semifinals Playoffs Tickets Sweepstakes (the "Sweepstakes") is open only to entrants who are legal residents of Pennsylvania, New Jersey or Delaware, 18 years of age or older as of the date of entry. The following persons are not eligible to enter or win: employees of CS Philadelphia Lacrosse Team, LLC ("Sponsor"), the National Lacrosse League and its member teams and each of their respective parents, affiliates, subsidiaries, and advertising and promotion agencies and Prize Providers (as defined below), and the immediate families (spouse, parents, siblings and children, and their respective spouses, regardless of where they reside) and members of the households, whether or not related, of each of the above. Additional entries beyond the specified limit will be void. Entries generated by script, macro or other automated means and entries generated by any other means which subvert the entry process will be void. Each entrant must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete and/or inaccurate entries are void.
